Golf Cart Rental Agreement – Assumption of Risk Agreement Voluntary Release

I hereby waive, release covenant not to sue and to hold harmless the owners and operators of the golf course or any of their officers, employees, or agents from any and all claims of damage in connection with my rental and use of the golf cart(s), except to the extent such damage was caused by the intentional acts or gross negligence of such entities or persons. This agreement shall apply to myself as well as those who, under my permission, may use or ride in said golf carts(s). I am aware that certain risks may result from the use or operation of said golf carts(s). These risks include, but are not limited to: collisions involving other golf carts, injury to persons or property while participating in the game of golf and injuries caused by an errant golf ball. I agree to assume all of the above-mentioned risks. Further, I agree to return said golf cart(s), following its intended use in as good condition as I received. I agree to pay for any damages that are sustained to the golf cart(s), while in my possession. I understand I should follow the recommendations that are located on each golf cart windshield when I see signs of inclement weather in the area. I am aware that Deerfield will deploy an audible sound to notify guests of inclement weather in the area and that I should follow the recommendations located on the windshield of each golf cart. I have read this agreement and fully understand its contents. By signing this Agreement, I understand that I am releasing the owners and operators of the golf course and their officers, employees, agents and all other representatives of any and all liability.

Rules of Operating a Golf Cart

1. Only two persons and two sets of golf clubs are allowed per golf cart
2. Please utilize cart paths around tees and greens
3. All traffic controls must be adhered to at all times.
4. Wet areas and tall grass areas must be avoided at all times.
5. A valid drivers license is required to operate golf carts.
6. Management reserves the right to refuse the use of any golf cart for any reason.
